Collected data of the visitor from Network Vitalis Crop

Information lacking in personal identification.

Visitors who approach Vitalis Crop's website do not incur in the danger that their data are recorded, that is information such the name, address, the tax identification number or the e-mail account. Therefore the Network Vitalis Crop makes known that the only collected data are those of statistical type concerning: IP address of the navigator, the pages that have visited, the dates and the times, the kind of dominion, the browser, the measure of the screen and the number of the colors. Collected information lacking in personal identification from the Network Vitalis Crop are used for internal scopes in order to improve the website and the services. Information lacking in personal identification can be shared with trading partners (third parties) of the Network Vitalis Crop on *blind base* (e.g. demographic information to statistics of the website). These data will never be supplied in conjunction with data of personal nature or information that can directly connect the third parties with a particular visitor. If the visitor spontaneously supplies to the Network Vitalis Crop information of personal identification and has allowed the Network Vitalis Crop to use them for several purposes, the information itself could

be associated to the information lacking in personal identification for internal scopes. In any case data will never be shared with third parties (except for administrative purposes) or made available to the public.

Data with personal identification.

The Network Vitalis Crop does not use or snatch information of personal identification without previous authorization of the visitor. The data of personal identification include the name, the address, the tax identification number or the e-mail account. The Network Vitalis Crop, upon performing with customers, suppliers and third parties, engages itself to make sure that there is a warning and an option to be chosen for all the visitor before using information of personal identification for whichever purpose but the administrative ones and for what is strictly necessary. The Network Vitalis Crop will never demand information of the visitor about sexual or political orientation, religious guideline or data on the health. All the supplied information of personal identification from the visitor will be treated in confidential way and will have the same level of respect and cure that the Network Vitalis Crop reserves to its personal information and the secrets trade ones. The Network Vitalis Crop for any reason will never alienate, neither rent, exchange or barter information of personal identification with nobody for economic or trading purposes. The Network Vitalis Crop however can supply this type of information to its commercial partners for what concerning transactions such as buy and sell, the payment, the transport of assets or services acquired. Everyone of the business partners will have to agree with this charter and to maintain the same line of conduct.

Security

The Network Vitalis Crop will act by using the best techniques in its possession in order to maintain the security of the website and the collected information. All the data recorded in the computers of the Network Vitalis Crop are treated like confidential and they are not available to the public.

The Network Vitalis Crop has an internal charter of security for the respect of the privacy and confidentiality of the data and limits the access to the data only to the collaborators who of they have really need in order to carry out their job.

Information lacking in personal identification - Use of the Cookies - Option.

In spite of cookies are not necessary in order to navigate on the website, they are essential in order to authenticate the user and to approach the restricted areas and for being able to carry out requests and/or purchases.

The user can choose not to use the cookies by disabling or deleting them. The procedure of disabling and/or deleting of the cookies can anytime be executed through functions available in the browser of navigation.

Data of personal identification - Option.
